Our review of your recent letters requesting to add new Authorized User (AU) Brian Seile & to update RSO office location We expect to receive a written response within 14 days (on or before the close of business on March 10, 2015).

**SUMMARY AND ACTION REQUIRED:**

We have reviewed your December 30, 2014, and January 7, 2015, letters, requesting, respectively, addition of Brian Seile as the listed Authorized User (AU), and revision of office location for the Radiation Safety Officer (RSO), to DCS Corporation, 295 Foster Street, Suite 120, Littleton, MA 01460. We have also reviewed our records concerning our June 20, 2013, phone conversation with you, concerning the pending commencement of licensed activities at your facility.

Additional information is needed to complete our review of your amendment request(s) and/or notification; it is also needed to clarify your status surrounding possession and/or use of radioactive materials under the above referenced license.

1.2. Outline for the Dade Moller Radiation Safety Academy 40-hour RSO training course, demonstrating topics covered sufficient for oversight of the possession, use, and storage of radioactive materials under the above referenced license.
