Dear Ms. Ebbert, P.G.:

This refers to your license amendment request. Enclosed with this letter is the amended license.

By letter dated December 16, 2014, McCallum Testing Laboratories, Inc. notified the U.S. Nuclear Regulatory Commission (NRC) that it was transferring control of licensed operations to McCallum Testing LLC. The letter requested an amendment to the licensee name and for direct change of control of NRC Materials License No. 45-15325-01. A letter dated January 7, 2015, was sent with additional information. Based on the information the NRC staff understands that as a result of the direct change of control, the license will be transferred to McCallum Testing LLC dba McCallum Testing Laboratories. The NRC staff further understands that this transfer will not result in any change to the licensee's licensed material, persons using the licensed material, location of the use of licensed material, or persons responsible for the licensee's radiation safety program. It will result in the licensee's name to be changed to McCallum Testing LLC dba McCallum Testing Laboratories.

Based on the above understandings, and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, which documents the NRC staff's safety review of the request, the NRC consents to the proposed transfer and has issued this license amendment reflecting that change. Please note that any future changes in the licensee name, licensed use, licensed materials, licensed location, or persons responsible for licensed material require submission of a request to amend the license and NRC consent or approval must be received prior to implementation of the proposed change.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically
