Dear Dr. Kolodziej:

This letter forwards NRC Form 591, "Safety Inspection," indicating that no items of non-compliance were found during the above described inspection of your licensed activities. Please retain the form in your files. No acknowledgment of this letter is required. However, should you have any questions, we shall be pleased to discuss them with you.

During the inspection we discussed with you and your Radiation Safety Officer (RSO), Mr. Rhoe, the NRC requirements for facility decommissioning. Since the facility has remained shut down and you notified us by letter dated March 22, 2014, that no principal activities were conducted for a period of 24 months, you are required to submit a decommissioning plan (DP) within 12 months of notification, if your decommissioning procedures involve techniques not applied routinely during cleanup or maintenance operations. Therefore the DP, if needed, must be submitted by March 22, 2015. Further, as noted in our letter dated December 3, 2014, decommissioning must be completed within 24 months (March 22, 2016) of the notification unless an alternative decommissioning schedule for the facility is approved by the NRC.

In order to maintain compliance with NRC requirements, you agreed to promptly review your position with regard to decommissioning and reach a decision going forward for the facility. This included possible sale of the property to another local company affiliated with medical operations, or coordinating with Mr. Rhoe to engage the services of a decommissioning contractor to provide cost estimates for work activities.
