Dear Mr. Judge:

This refers to your letter dated October 29, 2014 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML14323A202) to the U. S. Nuclear Regulatory Commission (NRC) requesting Consent to Direct License Transfer of NRC Materials License No. 44-30912-01. Based on the information you provided, we understand that as a result of a proposed sale between R.O.V. Technologies, Inc. and R. Brooks Associates, Inc., a New York corporation doing business as (d/b/a) Rolls-Royce, control of the licensed activities will be directly transferred to R. Brooks Associates, Inc., d/b/a Rolls-Royce. We further understand that this transfer will not result in any change to the licensed materials, persons using licensed material, location of use of licensed material, or persons responsible for the licensee's radiation safety program.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, the NRC consents to the proposed transfer. This consent will be valid for 90 days from the date of this letter; if the transfer is not completed within 90 days you will need to request an extension from the NRC before the end of the 90-day period.

Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the sale agreement confirming completion of the transaction. With this information, we can issue an administrative amendment to your NRC license to reflect the transaction, if necessary.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice for Domestic Licensing Proceedings and Issuance of Orders," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's expectations for individuals and organizations to establish and maintain a positive safety culture.
