AMERICAN CENTRIFUGE PROJECT CLASSIFIED AREA AT CURTISS-WRIGHT
ELECTROMECHANICAL CORPORATION – TECHNICAL ASSIGNMENT
CONTROL NUMBER L34295

Dear Mr. Toelle:

This is in response to your letter number ACM 14-0015, dated August 18, 2014, requesting the U.S. Nuclear Regulatory Commission (NRC) conduct a close-out inspection and terminate the facility security clearance for the American Centrifuge Project (ACP) classified area at the Curtiss-Wright Electromechanical Corporation (CW) facility in Cheswick, Pennsylvania. In your letter, you stated that due to the funding status for the ACP, USEC Inc. (USEC) had determined that this area is no longer required. Following your request, by letter dated November 4, 2014 (ACM 14-0018), you requested that CW instead be reclassified as a non-possessing facility and that the Cognizant Security Agency (CSA) be transferred from the NRC to the U.S. Department of Energy (DOE), Oak Ridge Office.

The NRC staff has completed its review of your submittals. On October 21, 2014, the NRC staff conducted a final inspection of the CW classified area for the purpose of terminating the facility's security clearance. Based on the results of this inspection, and as requested in your November 4, 2014, letter, the NRC staff will reclassify CW as a non-possessing facility. In addition, as you requested, the NRC will transfer the CSA responsibility from the NRC to DOE. These actions will be reflected in a revised Facility Data and Approval Record (FDAR) to be issued by DOE. Once the FDAR has been updated, the NRC will no longer have regulatory oversight of activities at CW.

This action closes efforts under Technical Assignment Control number L34295.
