In response to the Nuclear Regulatory Commission's request for additional information resulting from a telephone conversation on 25 Feb 15, the information provided below will address items 2, 3 and 4 of the conversation record. At your specific request, item 1 is addressed in the attached cover letter.

With regards to item 2, although Melinda Caron's (RSO) physical address has changed from Waltham to Littleton MA., the mailing address remains at 7400 Miller Dr., Warren, MI.

Concerning item 3, Melinda Caron retains responsibility for all licensed activities in accordance with procedures outlined in license number SUB-1603 and for managing its program in accordance with NRC regulations.

Regarding item 4, DCS has not received any radioactive materials to date, however we request a continuance of said license, as the work stipulated within is dependent on the requirements of the U.S. Government, and as such, DCS Corporation must remain prepared and positioned to accomplish contract work as stipulated in the license. At this time, there is no estimated start date, as the licensed work is based solely on the needs of the U.S. Government. DCS does not intend to use licensed material for any purpose, without appropriate submission of an amendment request and approval and authorization by NRC.
