

The table in Modification M0019 incorrectly listed the allocation of funds for Modification **M0018**. The modification listed \$250,000.00 under Job Code D2316, however the funding should have been allocated as follows: **Job Code R0125 - \$70,000.00 & Job Code D2316 - \$180,000.00** for a total of \$250,000.00. Also, modification M0019 listed the incorrect ceiling total for Job Code R0125. The current ceiling total for Job Code R0125 is being corrected from \$10,636,462.55 to **\$10,754,881.26**.

Accordingly, the following changes are hereby made:

Article B.4 Consideration and Obligation – Reimbursable Services – (C005/D2316)

(a) The total estimated amount of this contract (ceiling) for products/services ordered, delivered and accepted under CLIN 005 is \$1,925,363.28
