

I am asking for the included amendment application for license XSOU8783 allowing Materion Advanced Chemicals, Inc. to export Thorium Fluoride to II-VI Singapore Pte, Ltd. to be considered for expedited approval.

We have been recently made aware that the Nuclear Regulatory Commission believes we are over the maximum cumulative total outlined in the above license. We do not believe this to be the case, based on our interpretation of the license and amendment from 2011. We would prefer to resolve the issue by applying for the amendment described in the attached Form 7, which extends the expiration of the license and increases the cumulative amount allowed for Materion to export.

We thank you for your consideration of expediting the approval of the amendment. We would prefer to be approved so that we can resume shipping to our customer by May 1, 2015.
