**SUBJECT: NRC INSPECTION REPORT NO. 03009164/2014002, CHARLESTON AREA  
MEDICAL CENTER, CHARLESTON, WV SITE AND NOTICE OF VIOLATION**

Dear Dr. Artz,

On November 18, 2014, Randolph Ragland of this office conducted an inspection at your blood bank located at 3200 MacCorkle Avenue, S.E., Charleston, WV, of activities authorized by the above listed NRC license. The inspection continued in-office until March 23, 2015. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. Additional information received by electronic mail on March 5, 2015, was also examined as part of the inspection. The findings of the inspection were discussed by telephone with Charlotte Rayhill and Patricia Williamson on March 23, 2015.

Based on the results of this inspection, the NRC determined that one or more violations of NRC requirements occurred. Because of the security-related nature of any such violations, the number and characterization will not be provided in this letter, but instead are provided in non-public enclosures. The violation(s) were evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation(s) is/are cited in the Notice of Violation (Notice), provided as Enclosure 1 to this letter. The violation(s) is/are cited because the violation(s) was/were identified by NRC. Enclosure 2 provides a description of the corrective actions taken by CAMC, LLC to address any violations.

The NRC has concluded that information regarding the reason for the violation(s), the corrective actions taken and planned to correct the violation(s) and prevent recurrence is already adequately addressed in our records. Therefore, you are not required to respond to this letter unless the description of your corrective actions in Enclosure 2 does not accurately reflect your corrective actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.
