On March 13, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Three Mile Island Station, Unit 1. The NRC inspectors discussed the results of this inspection with Mr. Tom Haaf, Plant Manager, and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
