By letter dated May 6, 2013, Entergy stated its intent to implement severe accident mitigation alternatives (SAMAs) IP3-053 by April 30, 2014, and IP2 and IP3 main steam system safety valve gagging devices by August 31, 2014. During the telephone conference call, Entergy confirmed that those three SAMAs have been implemented. Additionally, Entergy confirmed that IP3-052 had been implemented, as is stated in its May 6, 2013, letter.
