Enclosed is Amendment No. 10 to your NRC Material License No. 42-32507-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

We reviewed your amendment request dated January 13, 2015. Based on your provided information, we have concluded that all licensable radioactive material has been removed from your facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, we have authorized the release of facilities located at 1944 Griffith Avenue, Griffith, Indiana, for unrestricted use.

In addition, we have revised License Condition 13 and added License Condition 14, regarding the leak test requirement for sealed sources not associated with 10 CFR Part 34.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
