**Requirement to Submit Complete and Accurate Information: Petition for Rulemaking (PRM); Consideration in the Rulemaking Process: 10 Code of Federal Regulations (CFR) Parts 30, 40, 50, 52, 60, 61, 63, 70, 71, and 72 (Docket Nos. PRM-50-107; NRC-2013-0077)**

On March 17, 2015, the NRC published a document in the *Federal Register* ([80 FR 13795](#)) regarding a PRM filed by James Lieberman (the petitioner). The petitioner requested that the NRC amend its regulations to require that all persons seeking NRC approvals provide the NRC with complete and accurate information. The NRC determined that the issues raised in the PRM have merit and are appropriate for consideration in the rulemaking process. The docket for the PRM, PRM-50-107, closed on March 17, 2015.

**Radiation Protection: Advance Notice of Proposed Rulemaking (ANPR); Extension of Comment Period: 10 CFR Part 20 (Regulation Identifier Number (RIN) 3150-AJ29; NRC-2009-0279)**

On March 18, 2015, the NRC published a document in the *Federal Register* ([80 FR 14033](#)) extending the comment period for an ANPR published in the *Federal Register* on July 25, 2014 ([79 FR 43284](#)). The ANPR was published to obtain input from members of the public on the development of a draft regulatory basis that would identify potential changes to NRC's current radiation protection regulations. The deadline for submitting comments is now extended from March 24, 2015, to June 22, 2015.

**List of Approved Spent Fuel Storage Casks: Holtec HI-STORM FLOOD/WIND System; Certificate of Compliance No. 1032, Amendment No. 1, Revision 1: Direct Final Rule; 10 CFR Part 72 (RIN 3150-AJ52; NRC-2014-0275)**

On March 19, 2015, the NRC published a direct final rule in the *Federal Register* ([80 FR 14291](#)) amending its spent fuel storage regulations by revising the Holtec International, Inc., HI-STORM FLOOD/WIND System listing within the "List of approved spent fuel storage casks" to add Amendment No. 1, Revision 1, to Certificate of Compliance (CoC) No. 1032. The companion proposed rule also was published in the *Federal Register* ([80 FR 14332](#)) on March 19, 2015. This direct final rule is effective June 2, 2015, unless significant adverse comments are received by April 20, 2015.
