SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

Dear Mr. Reigner:

This letter refers to your application dated March 26, 2015, requesting of transfer the ownership of Nuclear Regulatory Commission (NRC) Exempt-Distribution Materials License No. 37-35178-01E to Masterweld Products LLC. In reviewing your application, we found that additional information is required.

Please note that 10 CFR 30.34(b), states: "No license issued or granted pursuant to the regulations in this part and parts 31 through 36, and 39 nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall, after securing full information, find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing." Therefore, control of licenses cannot be transferred without the prior written consent of the Commission, and no products can be distributed in the location listed in your letter until your request is granted.

Please provide the following information concerning changes of control, if any items are not applicable, so state.

1. Describe any planned changes in the organization, including, but not limited to transfer of stocks or assets and mergers, change in members on Board of Directors, etc..
2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel, and any changes in the training program.
3. Describe any changes in the location, facilities, equipment, radiation safety program, use, possession, and waste management, or other procedures that relate to the licensed program.
4. Describe the status of the licensee's facilities, equipment, and radiation safety program, including any known contamination and whether decontamination will occur prior to transfer. Include the status of calibrations, leak tests, area surveys, wipe tests, training, quality control and related records.

5. Confirm that both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions.
6. Confirm that the transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the NRC may be withheld from public disclosure. In order to do this, you must follow the procedures in 10 CFR 2.390(b) including and requesting to withhold at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).
