Enclosed is Amendment No. 08 to your NRC Material License No. 13-32719-01 in accordance with your request. Please note that the major changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

We noted that Condition No. 12.B. of your license, as it appeared on Amendment No. 07, listed Brion Shin, M.D. twice for different authorizations. It appeared that this was an error and that Dr. Shin should be listed once for both authorizations. We have combined Dr. Shin's authorizations in this amendment and removed the extraneous listing at this time.


