SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON APRIL 2, 2015

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on April 2, 2015. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP), Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS), Units 2 and 3.

Summary of Meeting:

Westinghouse Electric Company and SNC discussed that a vent was removed from Wall 11 as it was no longer needed. At the end of the open portion of the meeting, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before ending the open portion of the meeting.
