The Reference 1 letter transmitted NRC Inspection Report 05000445/2014404 and 05000446/2014404, which provided the results of a security baseline inspection conducted during the week of August 25, 2014 at Comanche Peak Nuclear Power Plant (CPNPP). The letter identified an apparent violation that is being considered for escalated enforcement as a preliminary Greater than Green finding. The letter also provided Luminant Generation Company LLC (Luminant Power) the opportunity to either: 1) attend a Regulatory Conference; or 2) submit Luminant Power's position on the finding to the NRC in writing within 30 days of the receipt of the letter. Luminant Power responded with the Reference 2 letter and elected to submit Luminant Power's position on the finding in writing.

The attachment to this letter, which contains security related information (SRI), provides information concerning the violation including: 1) the reason for the violation; 2) the corrective steps that have been taken and the results achieved; 3) the corrective steps taken to avoid further violations; and 4) the date when full compliance was achieved. The attachment also includes a discussion of mitigating factors associated with the violation.

This communication contains no new licensing basis commitments regarding Comanche Peak Units 1 and 2.
