SUBJECT: SUMMARY OF CATEGORY 2 PUBLIC MEETING (WITH
PORTIONS CLOSED) WITH WESTINGHOUSE ELECTRIC
COMPANY LLC. ON MARCH 27, 2015

The U.S. Nuclear Regulatory Commission (NRC) held a Category 2 public meeting, with a closed portion, with WEC on March 27, 2015, as a result of inspection report (IR) 999001426/2013-201 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML13163A042). The NRC performed the inspection at Western Zirconium, a Westinghouse Electric Company (WEC) facility, on May 7-8, 2013. Subsequent to the inspection the NRC issued inspection report IR 999001426/2013-201 and Notice of Violation (NOV) 999001426/2013-201-01 dated June 24, 2013. WEC responded to the IR and NOV on July 22, 2013 (ADAMS Accession No. ML13213A226). WEC then revised their response in letter dated September 13, 2013, to clarify they are contesting NOV 999001426/2013-201-01 (ADAMS Accession No. ML13269A197). The Office of New Reactors, in conjunction with the Office of Enforcement and Office of General Council reviewed the contested violation. As a result of the NRC review, a revised NOV / Enforcement Action (EA) EA-13-176 was issued to WEC on February 4, 2015 (ADAMS Accession No. ML13361A245).

On March 27, 2015, teleconferencing difficulties occurred during the public portion of the meeting and some members of the public may have experienced difficulties participating.
