I just got off the telephone with Terry, who returned yesterday.

He had received my voice-mail message and apparently had a brief update from Ms. Young, too. He says that as soon as he gets in touch with Ben Rhodd and they figure out when they will be able to do the reconnaissance, he will be back in touch with me.

I offered any help we can give. We talked briefly about the conference call, and the purpose of the reconnaissance survey that he and Ben will be doing. I said that we thought they probably could visit all three project locations during the same trip. I told him the plan was to have a face-to-face meeting in late June or early July (I didn't have my notes), when

the tribes had their draft SOW in hand, to hammer out final details. I also told him that we had already identified and responded to some issues during the conference call (e.g., daily rates).
