The Yankton Sioux Tribe takes strong opposition to the proposed "field study" submitted in the letter dated October 31, 2012 for the Crow Butte, North Trend, Marsland, and Three Crow In-Situ Uranium Recovery Projects. The Yankton Sioux sees this as not only a breach in your federal responsibility in the 106 process but also in our trust relationship. The Yankton Sioux has consulted on this project for only over a year now. It is my opinion that you are not capable of your position, take a hard look at the situation you have put your agency and now the Sioux tribes in. It

is well beyond an apology. What more can be said that the Sioux Tribal Historic Preservation Officers have not yet put in writing. Everything is clear to us. You and your agency are clearly intending to manipulate federal law. And its so sad that the environment is the one who is really being hurt here. This whole time your agency was just trying to appease the Sioux tribes so you can make your NEPA deadline. I am at loss for words and am frankly disgusted with the Nuclear Regulatory Commission.
