Nate - As we discussed, Cameco and Powertech are offering to pay travel expenses for the upcoming tribal visits to promote the consultation. Specifically:

1. Upon request. Submit email requests to Ken Vaughn at Cameco at:
Kenneth_Vaughn@cameco.com.
2. Limited to any of the 23 tribes to which NRC sent letters that have expressed both an interest in attending and the inability to pay.
3. Two (2) persons per tribe maximum.
4. Mileage rate = \$0.51/ mile.
5. Travel distance calculated from tribal headquarters to Pine Ridge Casino. Use NRC notification address unless a different address is provided by the tribe.
6. Expenses (lodging, meals, etc.) for less than or equal to 600 mile one-way travel distance: per person, \$100/day for four days.
7. Additional expense allowance for greater than 600 mile one-way travel distance: per person, \$125/day for two additional days.
