Subject: RAI, Lab surveys

Discussion: I asked Mr. Baker why the scoping surveys performed by AMEC Environment & Infrastructure, Inc. performed surveys in the areas not impacted. He stated that they were being conservative and wanted to get all labs with drains and hoods to ensure they were below action levels. I asked why lab 2276 had a final survey but was not on the impact list. He stated that it was a counting lab used for counting all of the smears from the other labs and was done at the end of the building use. I asked why Lab 1213 did not have a lose out survey. He stated only Iodine-125 was used in the lab and it had not been used since 1996 and thus a final survey was not done in that lab as it would have decayed away.

Action Required: Continue with reviewing the package.
