Dear Chairman Archambault:

Following the recommendation of the Wyoming State Historic Preservation Office and the Advisory Council on Historic Preservation, the U.S. Nuclear Regulatory Commission (NRC) has requested a formal Determination of Eligibility from the Keeper of the National Registry of Historic Places (the Keeper) concerning traditional cultural properties located within the area of potential effects for the Ross In Situ Uranium Recovery Project. The attached letter and its enclosures were sent to the Keeper on April 2, 2015, via overnight delivery. I have confirmed receipt of the information and the start of their 45 day review, which we estimate will conclude on approximately May 18, 2015. The enclosures to the attached letter to the Keeper are not being transmitted with this letter.
