**Software Maintenance Services**

On April 1, 2015, as a result of competitive procurement, blanket agreement call number NRC-HQ-7N-15-O-0001 was placed under NRC-HQ-13-A-09-0006 with Deloitte Consulting, LLP of Arlington, Virginia. The order provides for operations and maintenance support for the budget formulation system and Oracle Business Intelligence Edition software. The period of performance is from April 1, 2015, through September 30, 2015. The total estimated cost ceiling is \$170,948.

**Information Assurance Operations and Security Support Services**

On April 2, 2015, as a result of a non-competitive 8(a) set-aside procurement, labor-hour Contract Number NRC-HQ-11-15-C-0002 was awarded to Mystek Systems, Inc. of Catharpin, Virginia. The contract provides information assurance operations and security support services for the Office of Nuclear Security and Incident Response. The period of performance is from April 2, 2015, through April 1, 2016, with four 1-year option periods. The total estimated cost ceiling is \$2,950,344, inclusive of all options.

On April 15, 2015, the NRC published a direct final rule in the *Federal Register* ([80 FR 20149](#)) amending its spent fuel storage regulations by revising the NAC International, Inc., MAGNASTOR<sup>®</sup> System listing within the "List of approved spent fuel storage casks" to add Amendment No. 5 to Certificate of Compliance No. 1031. The companion proposed rule was also published in the *Federal Register* ([80 FR 20171](#)) on April 15, 2015. This direct final rule is effective June 29, 2015, unless significant adverse comments are received by May 15, 2015.

**Peach Bottom Extended Power Uprate**

On April 10, 2015, the NRC staff informed Exelon it did not object to power ascension of Peach Bottom Atomic Power Station, Unit 2, to the next hold point of 108% of the pre-extended power uprate (EPU) licensed thermal power. The decision is based on staff's review of the steam dryer stress evaluation at 104% power and supplemental performance information provided by the licensee. The Unit 2 EPU amendment issued in August 2014 requires submittal of steam dryer stress evaluations for staff review at specified power ascension hold points. The licensee increased power to 108% and expects to submit additional evaluation and performance information for the 108% hold point during the week of April 20, 2015. Staff will determine if the submitted information demonstrates reasonable assurance of steam dryer structural integrity to the full EPU power level of 112.4%.
