As the Seabrook project manager (PM), I have the responsibility for preparing and managing the review and issuance of license amendments, exemptions, relief requests, safety evaluations, and other documents associated with the safety and regulation of Seabrook. As the PM, I serve as the licensing authority regarding

the maintenance and amendment of Seabrook's licensing and design basis. My knowledge as a PM of Seabrook's licensing basis is intended to support the NRC's response to potentially significant events, generic safety issues and assessment of licensee performance.

My knowledge as a PM of Seabrook's design and licensing information makes the PM a necessary component in responding to allegations, controlled and routine correspondence, generic communications, and other requests for information from stakeholders. As the Seabrook PM, I serve as the primary licensing interface between headquarter organizations and licensees or regional offices in matters pertaining to Seabrook. As the PM, I integrate information obtained from all sources and ensure the proper dissemination to the applicable internal/external stakeholders.
