SUBJECT: NRC INSPECTION REPORT NO. 03003772/2014004, ELECTRIC BOAT CORPORATION, GROTON, CONNECTICUT SITE AND NOTICE OF VIOLATION

Dear Mr. Noonan:

On November 18, 2014, John Miller of this office conducted an inspection at the above address of activities authorized by your license. The inspection continued in-office until March 31, 2015. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. Additional information provided by Electric Boat Corporation that was received by the NRC on December 19, 2014, was also examined as part of the inspection. The findings of the inspection were discussed by telephone with Nick Dombrowski and other members of your staff at the conclusion of the inspection on March 31, 2015.

Based on the results of this inspection, the NRC determined that two violations of NRC requirements occurred. Because of the security-related nature of such violations, the characterizations will not be provided in this letter, but instead are provided in non-public enclosures. The violations were evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violations are cited in the Notice of Violation (Notice), provided as Enclosure 1 to this letter. The violations are cited because the violations were identified by NRC. Enclosure 2 provides a determination of severity level and a description of the corrective actions taken by Electric Boat Corporation to address the violations.

Enclosures contain Sensitive Unclassified Non-Safeguards Information. Upon separation, this cover letter is decontrolled.
