SUBJECT: SUMMARY OF THE MARCH 9, 2015, PUBLIC MEETING BETWEEN
THE U.S. NUCLEAR REGULATORY COMMISSION AND THE
PRESSURIZED WATER REACTOR OWNERS GROUP EXECUTIVE
COMMITTEE

On March 9, 2015, a Category 2 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and the Pressurized Water Reactor Owners Group (PWROG) Executive Committee (EC) in the Brookside Conference Room of the Bethesda North Marriott, 5701 Marinelli Road, Rockville, MD 20852. The PWROG EC desired to discuss PWROG organizational changes and the status of regulatory issues affecting the PWROG with the NRC's Office of Nuclear Reactor Regulation (NRR) management. A list of meeting attendees is enclosed and the meeting agenda dated February 25, 2015, is available in the Agencywide Documents Access and Management System (ADAMS) under Accession No. ML15055A384.

The meeting began with the introduction of attendees and opening remarks by NRR Deputy, Bill Dean, NRR Deputy Director, Jennifer Uhle, and EC Chairman, Adam Helflin. PWROG Chairman, Jack Stringfellow, started the presentation by informing the NRR management of the various PWROG organizational changes since the 2014 meeting. Mr. Stringfellow then led a review of the PWROG/NRC actions from the 2014 meeting. The floor was relinquished to PWROG Licensing Chairman, James Morris, who led a discussion on topical report activities. Next, various PWROG members led the discussions of the regulatory issues of mutual interest to the PWROG and NRC. The topics of discussions included: updates on the PWROG Generic Safety Issue (GSI) 191 program, updates on the PWROG Fukushima activities, PWROG perspective on the Title 10 of the *Code of Federal Regulation* (10 CFR) 50.46c rule, and PWROG perspectives on the Regulatory Information Summary (RIS) on pressure boundary leakage.
