## INSTRUCTIONS TO STUDENTS

**ACCEPTANCE:** This is to advise you that individuals listed in Enclosure 1 have been accepted for participation in the MARSSIM (H-121). This course is scheduled to be presented at the U.S. Nuclear Regulatory Commission's (NRC's) Professional Development Center (PDC) August 10-14, 2015. The PDC is located at our new 3 White Flint North Building which is situated across Marinelli Road from One White Flint North between the White Flint Metro station entrance and the Metro parking garage. The address for the new building is 11601 Landsdown Street, North Bethesda, MD 20852. Please allow sufficient time to process through security upon arrival. Please select a fully refundable Government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835.
