Pursuant to 10CFR72.56 this letter transmits a license amendment request (LAR) for the Oconee Nuclear Station ISFSI. It is requested that an amendment be made to update the ISFSI license such that the corporate name of the licensee is changed from Duke Power Company to Duke Energy Corporation. The purpose of this LAR is to implement the corporate name change that resulted from the merger of Duke Power Company and PanEnergy Corp. A LAR to similarly change the Oconee 10CFR50 Facility Operating Licenses (Nos. DPR-38, DPR-47, and DPR-55) was submitted by Duke letter dated June 12, 1997 and approved by NRC letter dated September 16, 1997.

Duke is requesting that the NRC review and approve this LAR in a timely manner. Prior to NRC approval, no impact on the status of Materials License No. SNM-2503 or the continued operation of the Oconee ISFSI is foreseen, since this LAR contains proposed changes that are solely administrative in nature. Additionally, the changes proposed in this LAR have resulted in no impact on the operation of the Oconee ISFSI during the period since the closure of the Duke/PanEnergy merger.

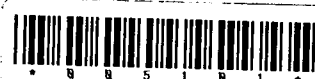


