Response to NRC Administrative Letter 98-03:
Operating Reactor Licensing Action Estimates

On May 6, 1998, the NRC issued Administrative Letter 98-03 to request addresses, on a voluntary basis, to submit estimates of the licensing actions expected to be submitted in the remainder of Fiscal Year (FY) 1998 and FY 1999.

The major licensing activities for this time frame includes:

- Oconee license renewal (submittal in July 1998)
- Improved Technical Specifications for Catawba, McGuire, and Oconee (awaiting SERs)
- Transition to Westinghouse fuel at Catawba and McGuire (license amendment submittal in July 1998)

In addition to these major activities, Duke estimates submitting a modest amount (less than 5 per station per year) of cost beneficial licensing amendments and code relief requests.

Also, attached is a list of Topical Reports that we anticipate submitting for review and approval.
