April 1, 1998 Presentation

On April 1, 1998, Duke Power Company personnel met with Nuclear Regulatory Commission Region II staff in the Region II offices to discuss the security computer/access control replacement projects underway at Catawba, McGuire and Oconee Nuclear Stations. A presentation was provided by Duke personnel on the features of the new security computer/access control system and the status of the security modifications at each nuclear station. Plans for the submittal of a revision to the Nuclear Security and Contingency Plan to reflect the security system upgrade were also discussed. The Nuclear Security and Contingency Plan is applicable to all three nuclear stations.

Catawba Nuclear Station began using new access control hardware and a new security badge for employee access into the protected area on February 23, 1998. In accordance with 10 CFR 50.54(p)(2), a revision to the Nuclear Security and Contingency Plan will be submitted to the NRC within sixty (60) days of this change. Revision 7 will address the new access control hardware and security badge in addition to other changes to the security system.

Upon issuance, Revision 7 will be temporarily inserted into Appendix 6 of the Nuclear Security and Contingency Plan. Revision 7 will be effective for each station when the security computer/access control system is fully implemented and Revision 7 pages are inserted into the applicable chapters of the Nuclear Security and Contingency Plan.

The projected completion dates for the security modifications are: Catawba Nuclear Station (April 30, 1998); McGuire Nuclear Station (August 31, 1998) and Oconee Nuclear Station (September 15, 1998).
