1. Specifications for all electrical wire and cables used in the construction, renovation, installation, maintenance, or operation of any nuclear power plant, as published or otherwise set forth by the Nuclear Regulatory Commission, the U.S. Atomic Energy Commission, Department of Energy, or any other predecessor agency between the years 1966 and 1982. This request seeks specifications, standards, and requirements for power wires/cables, control wires/cables, monitor wires/cables and any other electrical wire or cable of any other type or application used in nuclear power plants for the time period specified (1966-1982).
2. Any Preferred Vendor or Qualified Products Lists for electrical wire or cables used in the construction, renovation, installation, maintenance, or operation of any nuclear power plant, as maintained by the Nuclear Regulatory Commission, the U.S. Atomic Energy Commission, Department of Energy, or any other predecessor agency between the years 1966 and 1982.
3. Any records of sales or shipments of electrical wire or cable to the Millstone Nuclear Power Plant in Waterford, Connecticut or the Millstone Point Company in Waterford, Connecticut between the years 1966 and 1982.

We respectfully request complete, legible copies of the items specified above, along with an affidavit or certification executed by a qualified records custodian for the agency or department making the production. We agree to pay duplication fees for the processing of this
