Accordingly, Section A.1 CONSIDERATION AND OBLIGATION - COST-PLUS-FIXED-FEE (AUG 2011) ALTERNATE I (AUG 2011) paragraph (c) of this task order is revised as follows:

(c) The amount currently obligated by the Government with respect to this contract is \$625,000.00, of which the sum of \$589,622.63 represents the estimated reimbursable costs, and of which \$35,377.37 represents the fixed-fee.
