The following additional information is needed to complete the review of your request to remove the location of use at 1501 Hartford Street, Lafayette, Indiana, from your NRC license.

1. Please submit a history of radionuclides used at your old facility located at 1501 Hartford Street, Lafayette, Indiana. For example, millicurie quantities of technetium-99m in liquid form was used for diagnostic imaging studies. Microcurie amounts of cesium-137 in sealed source form was used for instrument calibration.
2. Please submit a copy of the leak tests for the sealed sources that was current on the date of the close-out survey.
3. Please specify if you ever had any leaking sealed sources.
4. Please confirm that the close-out survey date was on February 16, 2015.
5. Please specify the make and model number of the survey instrument used for the exposure rate measurements. For example, a Ludlum, Model 14-C, Geiger-Muller survey meter was used to measure the exposure rates for the close-out survey.
6. Please specify the make and model number of the instrument used to analyze the wipe test samples. For example, a Capintec Model Caprac-T, well counter was used to analyze the wipe test samples for the close-out survey.
7. Please specify the background radiation levels for the exposure rate measurements.
8. Please specify the radiation background for the wipe test samples.
9. Please specify the date of the Geiger-Muller survey meter calibration that was current at the time of the close-out survey.
10. Please provide confirmation that all radioactive waste and radioactive sealed sources have been removed from the old facility at 1501 Hartford Street, Lafayette, Indiana. Please provide a copy of the acknowledgement letter/papers that all radioactive materials have been received at your "East Campus" at 1701 S. Creasy Lane, Lafayette, Indiana.

Please include a cover letter on company letterhead, dated and signed (signed by an individual who is authorized to sign official documents on behalf of the licensee) with your response letter.
