SECRETARY CHILK: One item, Mr. Chairman, is COMSECY-93-019. It's a staff response to an SRM on SECY-92-351. The Commission is being asked to approve amendments to 10 CFR Part 61 containing licensing requirements for low-level waste disposal facilities. These amendments clarify that 10 CFR Part 61 also applies to the licensing of above-ground disposal facilities and update several other sections of Part 61. The changes should simplify the LLW disposal facility licensing interactions for NRC, the NRC agreement states and potential applicants for the LLW disposal licenses.

All the Commissioners have approved the final rule forwarded by the EDO on April 13th.


