Concurrently with the appeal, GPC filed an application for a stay of the Licensing Board Order pending a Commission decision on its appeal. All Commissioners have approved an Order which refers the stay request to the Licensing Board for further consideration. The Commission will decide the appeal in due course. Would you please affirm your votes?

MR. CHILK: The second item is SECY-92-364 dealing with Sequoyah Fuels Corporation request for hearing on license amendment application and withdrawal of license amendment application. The Commission is being asked to approve a Memorandum and Order in this paper which grants

2 amendment application dated April 1, 1992, and denies a
3 request for hearing filed by the Native Americans for a
4 Clean Environment and the Cherokee Nation on August 19,
5 1992. All Commissioners have approved the Memorandum and
6 Order which is attached to our memorandum dated the 18th of
7 March. Would you please affirm your votes.
