Dear Mr. Heacock:

On April 2, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection of the physical security program for the Independent Spent Fuel Storage Installation (ISFSI) located at the permanently shutdown Kewaunee Power Station (KPS) in Kewaunee, Wisconsin. The purpose of the inspection was to verify that the security program and protection for the ISFSI was in compliance with the ISFSI Physical Security Plan (PSP), Safeguards Contingency Plan (SCP), Training and Qualification Plan (T&QP), NRC regulations, and U.S. NRC Safeguards Order EA-07-195, "Order for Implementation of Additional Security Measures (ASMs) and Fingerprinting for Unescorted Access for Certain Spent Fuel Storage Licensees - Kewaunee Power Station (KPS) Independent Spent Fuel Storage Installation (ISFSI)," dated January 28, 2008; in addition, the inspection also evaluated the handling and storage of safeguards information. At the conclusion of the on-site inspection on April 2, 2015, the inspectors discussed the inspection findings with Mr. Yuen and members of your security, licensing and ISFSI project management staff.

The inspection also examined activities conducted under your license as they relate to security and compliance with the NRC's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel. The enclosed inspection report documents the inspection results.

Based on the results of this inspection, no findings of significance were identified.
