On March 10, 2015, the U.S. Nuclear Regulatory Commission (NRC) issued the subject Turkey Point Nuclear Plant – NRC Physical Security Inspection Report 05000250/2015403 and 05000251/2015403, ADAMS Accession Number ML15077A528 (nonpublic version). In review of the report, errors were identified which require correction, accordingly, we are reissuing the inspection report (IR).
