Dear Dr. Sutkowski:

Enclosed is Amendment No. 101 renewing your NRC Material License No. 13-00142-02 in accordance with your request. Your license has been renewed for a ten year term and will not expire until April 30, 2025.

Please note that significant changes to your license may appear in bold font, such as format changes resulting from requests you made and updates that we have implemented at this time.

In this renewal, we deleted Condition No. 13, as it appeared on Amendment No. 100, because it was no longer necessary for your licensed program. Your other license conditions may have been re-ordered and re-numbered as a result of this change.

We also corrected and completed Condition No. 14 to bring it current. We adjusted and/or made requested changes to Subitem Nos. 7.F. (adding the new HDR source manufacturer) and 9.F. and Condition Nos. 10, 12 and 19.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents.
