**Purpose**

The purpose of this letter is to request the U.S. Nuclear Regulatory Commission (NRC) review and approval of a proposed change to the Security Program for the American Centrifuge Plant (NR-3605-0004) and the American Centrifuge Lead Cascade Facility, in accordance with 10 *Code of Federal Regulations* (CFR) 95.19. This change was determined not to decrease the effectiveness of the Security Program in accordance with 10 CFR 70.32; however, the change was determined to be a substantive change in accordance with 10 CFR 95.19 and requires NRC prior review and approval.


**Action**
