JOINT STATEMENT OF PARTIES REGARDING REDACTIONS OF CLI-15-09

On April 23, 2015, the Commission issued a non-public Memorandum and Order¹ denying a petition for review² filed by Nuclear Watch South, Blue Ridge Environmental Defense League, and Nuclear Information and Resource Service challenging the Atomic Safety and Licensing Board's Initial Decision.³ The Commission ordered the parties to, within 10 days of the decision, "jointly submit proposed redactions to this decision or a statement that no redactions are needed."⁴ The Commission noted that it would release a publicly available version of its Memorandum and Order as soon as practicable.⁵

Pursuant to the Commission's instruction, both Shaw AREVA MOX Services and the staff of the U.S. Nuclear Regulatory Commission reviewed the decision for any non-public information that should not be released to the public. Because neither review identified any such information, the parties jointly agree that no redactions to the Commission's Memorandum and Order are needed.
