SUBJECT: ACKNOWLEDGEMENT OF RECEIPT OF AMENDMENT REQUEST TO INCREASE FLOW RATE AT NORTH BUTTE REMOTE SATELLITE FACILITY TO THE SMITH RANCH HIGHLAND URANIUM PROJECT, SOURCE MATERIAL LICENSE SUA-1548 (TAC L00783)

Dear Mr. McGonagle:

By letter dated April 10, 2015, Power Resources, Inc. (PRI), doing business as Cameco Resources (Cameco), submitted a license amendment request to the U.S. Nuclear Regulatory Commission (NRC) staff for the North Butte remote satellite to the Smith Ranch Highland facility. The North Butte and Smith Ranch Highland facilities are both authorized under Source Material License SUA-1548 and are allowed to use in-situ recovery (ISR) techniques to extract uranium from below the ground surface. The license amendment request seeks to increase the allowable flow rate at North Butte from 4,000 gallons per minute (gpm) to 6,000 gpm. The NRC staff understands that Cameco is continuing wellfield development at North Butte and that Cameco anticipates needing the increased capacity later this year.

The license amendment request is currently in the process of being added to ADAMS. The staff has established a TAC for costs incurred during this review. Please include TAC L00783 on future correspondence related to this amendment request. Staff will inform you when the acceptance is initiated.
