On April 16, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at Grand Gulf Nuclear Station, Unit 1. An NRC inspector discussed the results of this inspection with Mr. V. Fallacara, General Manager Plant Operations, and other members of your staff. The inspector documented the results of this inspection in the enclosed inspection report.

The NRC inspector did not identify any findings or violations of more than minor significance.
