Enclosed is Amendment No. 60 renewing your NRC Material License No. 13-02650-02 in accordance with your request.

Your license has been renewed for a ten year term and will not expire until April 30, 2025.

Please note that significant changes to your license may appear in **bold** font, such as format changes resulting from requests you made and updates that we have implemented at this time.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**Please note that, although your letter dated January 26, 2015, did not explicitly confirm your intention and understanding regarding compliance with 10 CFR 35.3045(b) – (g), the regulations in 10 CFR 35.1000 and 10 CFR 35.3045(b) – (g) still apply to your yttrium-90 SIR-Spheres medical use program for medical event reporting and notification requirements.**

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
