This letter refers to the routine unannounced inspection conducted on March 17-18, 2015, at your facility in Los Angeles, California. On March 18, 2015, at the conclusion of the inspection, the inspector left you with a record of the inspection, an NRC Form 591M Part 1, which indicated no violations were identified during the inspection and that previous violations were closed.

The purpose of this letter is to inform you that we are formally rescinding that NRC Form 591M Part 1, and that we are continuing our review of the information gathered during that inspection. You should remove the NRC Form 591M Part 1 dated March 18, 2015, from your files. This matter was discussed during a telephone call between Ms. Sandra Fitchett of CampCo, Ms. Linda Howell, Deputy Director, Division of Nuclear Materials Safety, and Mr. Michael Vasquez, Chief, Nuclear Materials Safety Branch A, on May 6, 2015.

The NRC will inform you by separate correspondence when our review of information gathered from this inspection and other reviews of your program have been completed. Because our review of your program is ongoing, no response to this letter is required.
