Subsequent to the submission of your request, you agreed to narrow the scope of this request in several ways: (1) The time frame for the request is the same as a prior, identical, request, FOIA-2013-0106; (2) The responsive records include only emails (reflecting technical discussions) sent to, or by, the specified NRC staffer about Jocassee Dam and/or the flooding hazard at Oconee Nuclear Station, rather than emails this staffer may have received or sent subsequent to these technical discussions; and (3) excludes the attachments (Oconee IPEEE and an excerpt therefrom) to documents B/24a and B/25.

- Exemption 1: The withheld information is properly classified pursuant to Executive Order 12958.
- Exemption 2: The withheld information relates solely to the internal personnel rules and practices of NRC.
- Exemption 3: The withheld information is specifically exempted from public disclosure by statute indicated.

 - Disclosure will harm an identifiable private or governmental interest.
- Exemption 5: The withheld information consists of interagency or intraagency records that are not available through discovery during litigation. Applicable privileges:
 - Deliberative process: Disclosure of predecisional information would tend to inhibit the open and frank exchange of ideas essential to the deliberative process. Where records are withheld in their entirety, the facts are inextricably intertwined with the predecisional information. There also are no reasonably segregable factual portions because the release of the facts would permit an indirect inquiry into the predecisional process of the agency.

 - (F) Disclosure could reasonably be expected to endanger the life or physical safety of an individual.
