#### Status of Recommendations

Recommendation 25:

Update the agency's information management and security policies to include social media.\

- (A) Revise MD 3.53, *Records and Document Management Program* and include social media in accordance with the guidance provided in NARA Bulletin 2011-02, *Guidance on Managing Records in Web2.0/Social Media Platforms*.
- (B) Revise the existing PII Breach Notification Policy and Computer Security Incident Response Policy to include the following statement: *All of the information contained in this policy applies to the use of social media.*

- (B) The Office of Information Services (OIS) is currently updating Management Directive (MD) 3.53. The revision will include the social media guidance included in the National Archives and Records Administration (NARA) bulletin. OIS has changed the expected completion date for the revision of MD 3.53 to allow staff to incorporate new findings and recommendations from a recent NARA assessment report as well as the Office of the Inspector General's (OIG's) "Audit of NRC's Method for Retaining and Documenting Information Supporting the Yucca Mountain Licensing Process (OIG-14-A-18)."
- (C)(2) The Computer Security Office has updated the Computer Security Incident Response Policy to include a statement that the policy applies to the official agency use of social media to communicate NRC information.

(C) (2) Completed April 23, 2015
