The RSO's training and experience must include the uses of licensed material identified on the license so that the RSO is able to oversee the radiation safety program during normal and emergency conditions.

Please submit documentation of the proposed RSO's training and experience that demonstrates the above, including any hands-on experience in the use of the licensed material identified on the license.
