# **AREAS OF RAI RESPONSE CLARIFICATION**

The NRC staff will seek clarification and plans to hold discussion in the following areas related to the PWROG responses to the RAIs for the review of TR PWROG-14001-P/NP, Revision 1:

- Epistemic uncertainties associated with probabilities proposed in the TR in light of previous experience with Generation I and II Westinghouse Shutdown Seal (SDS). To that extent, the NRC staff wishes to discuss:
  - Engineering bases for eliminating previous issues encountered from the Generation I and II Westinghouse SDS in computing failure probabilities for the Generation III Westinghouse SDS (reference RAI APHB-8).
  - Assumptions and conditions applicable to the bench tests of the Generation III Westinghouse SDS assembly (reference RAI APHB-3).
  - Statistical bases for completely eliminating Generation I and II Westinghouse SDS data from the estimated failure probability of Generation III Westinghouse SDS and how that bases comports with High Level Requirements for Data Analysis of American Society of Mechanical Engineers/American Nuclear Society Standard RA-Sa-2009, endorsed by Regulatory Guide 1.200, Revision 2 (reference RAI APHB-4, APHB-5, and APHB-10).
- The PWROG views with respect to additional aspects of Integrated Risk-Informed Decision Making (RIDM) applicable to this licensing action. Specifically, the NRC staff is interested in discussing the "Performance Monitoring" aspect of RIDM as it applies to the TR.
