To Whom it May Concern:

Northwest Design Group (NDG) holds a Material License (#21-26560-01).

We are providing this letter to confirm that a direct transfer of control/ownership of the above mentioned Materials License has recently taken place. Details of the events:

- The new owner of the business is Northwest Design Group, LLC, a Michigan LLC. This LLC is 100% owned by Kingscott Associates, Inc., an engineering firm headquartered in Kalamazoo, Michigan. The LLC has purchased all of the assets of NDG used in NDG's business. The business will continue to operate as it has historically operated.
- The transfer of control/ownership took place on April 1, 2015.
- The business will continue to operate under the names "Northwest Design Group" and "NDG."
- The location of the business is not changing and will remain at 2940 Parkview Drive, Petoskey, Michigan 49770.
- The Radiation Safety Officer (RSO) is not changing and will still be Daniel W. Ulrich. His contact information (noted at the end of this letter) is not changing.
- There will not be any personnel changes in connection with these events. The personnel of NDG with responsibility and authority for the Materials License and related customer projects are not changing.

- There will not be any changes to equipment, storage and security facilities, or prescribed procedures in connection with these events.
- All records related to the Materials License and the activities performed pursuant to the Materials License, equipment ownership, inventory and maintenance will remain in the same location.
- All required surveillance programs have been performed, documented, and reviewed.
- Except for the change in the name of the licensee (from Northwest Design Group, Inc. to Northwest Design Group, LLC), none of the information in the Materials License is changing.
- The transferee (Kingscott Associate, Inc.) agrees to the change of control/ownership of the licensed material and confirms to abide by all constraints, conditions, requirements and commitments of the transferor's (Northwest Design Group) NRC Materials License.
